## Bob McClellan Memorial Walleye Tournament Rules-Regulations-Eligibility

1. Completed registration form must be mailed to **Stephanie McClellan, 560 Alder Lake Road, Manitowish Waters, WI 54545** or filled out the day of the tournament. To participate each team/boat must check in at Bear Country Builders/Bob & Carol's Garage, 5185 US Hwy 51 S, Manitowish Waters, WI 54545. If a team/boat does not check in they will not be eligible for prizes. Only fish caught during tournament hours (**8am to 4pm**) are eligible for prizes.
2. All teams/boats (Maximum of 4 people per boat) can fish any body of water they would like to within Vilas & Iron Counties. Keep in mind that all boats **must register fish by 5:00 p.m.** to be eligible for prizes.
3. All USCG and Wisconsin boating regulations will apply to all participating anglers.
4. Each angler must wear a PFD (Life Jacket) while the boat is under power.
5. No fishing from shore, piers or bridges will be allowed. All event anglers must fish from a boat.
6. Wisconsin hook and line fishing regulations apply.
7. No motor trolling will be allowed. Motor trolling is illegal and will cause disqualification.
8. Prizes will be awarded for:(based on the # of boats registered)
  - Ø Largest Five Walleye- decided by inches (**New for 2011, a person may register one walleye to qualify for prize monies**)
  - Ø Best Catch of Walleye per Boat by weight- divided by number of people in boat
  - Ø Kid's Category (children under 14years of age): Largest Walleye. Any fish registered in Kid's Category will also be eligible for Largest Walleye in Open Category.
9. In case of tie, in any category, **the first fish registered will be declared the winner.**
10. Event anglers must conduct themselves in a true sportsman like, courteous, safe and ethical manner while fishing. Safety first!
11. Prize winners are responsible for any and all taxes. If a minor (under 18) participant wins, the parent or guardian is responsible for all taxes.
12. Minors (under 18) must be accompanied by a parent or guardian (over 18) during the tournament and all related functions.
13. Any state regulations or event rules broken will result in automatic disqualification.
14. All anglers give the sponsors of the Bob McClellan Memorial Walleye Tournament all advertising and promotional opportunities.
15. All Teams/Boats **must be off the water at 4:00 p.m. and register fish no later than 5:00 p.m.** to be qualified for prizes.
